# Job Background

This project funded by The Armed Forces Covenant Trust aims to reduce veteran suicide, support those at significant risk of veteran suicide by strengthening psychological resilience and wellbeing of service veterans through a innovative programme and collaborative approach to service delivery. This project aims to support the following

Priority 1 – Veterans 25-45

Priority 2 – Veterans 45-65

### Operation Blue Sky has 4 main components

- 1. Delivery of week-long adventure-based therapy programme to groupings of 10-12 Veterans.
- 2. Delivery of Psychoeducation Courses running in tandem with ABT weeks in partnership with Elys Partners. each course (4-6 weeks) focusing on trauma/pain management and addictions.
- 3. Health and Well Being Individual Needs Review for all group participants and their dependents by in house Ely Health and Well Being Case Officers to assist group beneficiaries accessing eligible peace funded frameworks and referral to in house Ely Clinical Teams
- 4: Co Design implementation group composed of veterans/service users and Ely Staff to continually assess the impact of the project, set project eligibility and assess outcomes

### **Role Requirements**

The Successful candidate will be responsible for the development/co-ordination and implementation of the Project in line with funding requirements, company policy and procedures including:

- Promotion/ Recruitment and arrangement of Adventure therapy programmes amongst the Veteran target group, identify opportunities for group expansion, completing monitoring outcomes of project to the stakeholders and the wider veteran's community.
- Management of project budget and completion of interim reports to funding authority, Line manager and The Ely Board of Directors.
- Responsibility for maintaining a level of contact and reducing social isolation amongst the veterans taking part in the programme by offering advice/ support and guidance to them.
- Team Player: REFER into the other services provided by the Ely Centre staff covering welfare advice, financial support or health and wellbeing support to the clients if required

 Creative: Assist in the creation of social media output outlining the impact of service on the veteran's community and the benefit of AFCT funding and the Ely Centre on the Veterans Community.

# Why is this needed?

The OITM evaluation report highlights the growing concern that whilst the possibility suicide may be associated with military veteran status has not been confirmed within the UK, a finding which may be impacted due to paucity of research within the UK Context, international studies reporting 16 suicides per day (US Dept of VA, 2022) in the US and similar findings within Canada in comparison to the General Population, clearly are concerning and require the need for programmes to address suicidal prevalence within the UK Armed Forces Community.

OITM rightly asserts that there are many factors causing clients distress due to their current situation rather than anything resulting from military service, the need for projects which provide enthusiastic, innovative, timely and skilled care in a safe setting are required when engaging with Veterans at risk of suicide and delivering preventative action.

Whilst the factors which lead someone to take their own life remain extremely complicated and influenced by numerous situation factors predisposing factors identified within the study including unresolved trauma, traumatic exposure, family stress, operational factors, relationship problems, alcohol /substance abuse and isolation are factors targeted within the innovative approach the Blue Sky Project is seeking to address.

This project will addressing the above factors will implement a personalised care plan with a combination of social prescribing adventure-based activities, peer support and evidence based psychological support and treatment.



This project will implement the recommendations within the OITM report and through co design and delivery ensure that barriers hindering veterans from accessing support reduced and lives saved as a result of this programme.


- 2. Demonstrate experience of effectively engaging with and building positive relationships with clients in situations where they have been vulnerable.
- 3. Demonstrate experience of liaising with a broad range of service providers.
- 4. Demonstrate experience of providing progress reports and management information in clear and agreed formats, in line with a reporting schedule.
- 5. Demonstrate experience of successfully prioritising and managing your own workload while also communicating effectively with colleagues and management.
